



Verifying VAT Registration Numbers in SAP®





# **Initial Situation and Legal Requirements**

The ID for taxes on sales or purchases (VAT ID for short) is a unique company identifier within the EU. It ensures that goods and services traded on the EU market are handled correctly in terms of VAT. The VAT ID is added to the VAT Information Exchange System (VIES), an EU database for EU businesses liable to tax on sales or purchases, and can be consulted and checked by any EU citizen.

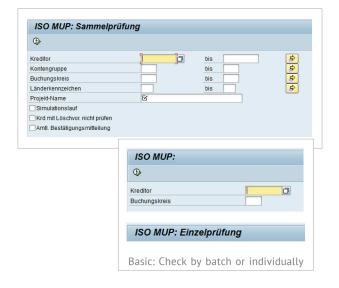
Pursuant to Section 6a Paragraph 4 of the German Value Added Tax Act, the supplying company is obliged to check the customer's details "with due commercial care". Suppliers need to comply with their due diligence of verifying the accuracy of the VAT ID. If it later turns out that the VAT ID of the recipient of the delivery provided by the suppliers was incorrect, they face significant back taxes. When checking the VAT identification number of customers in another member state of the EU, business operators have to provide the Federal Central Tax Office with their respective VAT ID (or possibly the tax number under which they are registered for VAT purposes) and the VAT ID to be checked as issued by another member state. As of 2020, the verification of the VAT ID is a substantive condition for tax exemption of supplies within the community.

# Integrated Solution for your SAP® Applications

The SAP Add-On Marlin VAT ID Check (MUP) supports your due diligence and implementing the requirements of the legislator. Seamlessly integrated in your SAP ERP 6.0, SAP CRM and S/4HANA systems, MUP automatically checks the validity of the data via several interfaces: the Federal Central Tax Office (BZSt in Germany), the Federal Ministry of Finance (FinanzOnline in Austria) and the European Commission (VIES for all other countries).

All relevant information is used to thoroughly check whether the respective foreign company has a valid VAT registration number – and whether the supplied information (company name, address, postal code) corresponds to the data registered in the respective EU Member State. The checks are stored directly in the system in a audit-proof manner.

The product MUP is available in two versions: MUP Basic and MUP Extended for the objects customer, vendor and central business partner. The versions differ in their integration with the respective object and its transaction data.

#### **Architecture**

The communication between the SAP system and the interfaces of the financial institutions (DE, AT and EU) takes place via the call of web services.

The SAP integrated add-on MUP is installed using workbench and Customizing requests, which are implemented by the transport and change management.

### **Complementary Add-Ons**

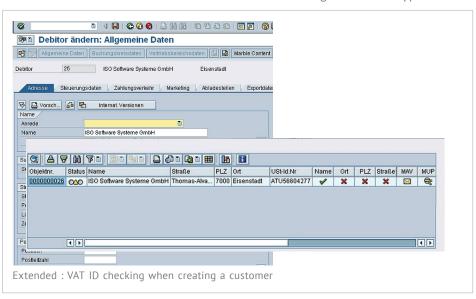

As a result, the addresses are corrected, normalized and enriched. In combination with the VAT ID check, corrected addresses allow for better results and fewer errors, especially in qualified checks.

Moreover, there is also a duplicate check for displaying VAT IDs that exist several times in the system.
